Fabric back panel (11)

- HDF 3 mm coated with foam 3 mm and fabric (fixing with glue stickers).

PET back panel (12)

- PET felt board 9 mm (fixing with glue, must be ordered separately).

Side and top panels (13)

- 16 MFC with 1 mm ABS edging;
- 16 mm chipboard, covered in wood veneer with 1,5 mm edging.

Keys for locks (14)

- Master key – provides lock access in case of forgotten/misplaced key;
- Removal key – allows removal of locks cylinder from the door;
- Cylinder lock with 2 keys – can be used to change the lock in case of lost keys.

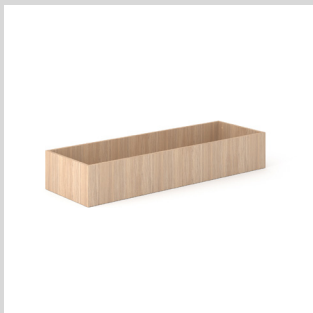

Additional information

Fixing one cabinet onto another

- The overall height of the cabinet will increase by 18 mm when placing one cabinet on top of the other (e.g. 1H+1H). This may result in differing overall heights between the cabinets or desks.
- Side panels will not be suitable for cabinet combinations.



- Please note glue on the stickers takes time to harden (50% in 15 min, 90% in 24 h and 100% in 72 h). It is advised to wait before first using the cabinet. Splitting the cabinets again by carefully removing the top part and cleaning the residual glue with everyday cleaning solvent (e.g. turpentine) is possible.
- Tips for fixing one cabinet onto another:
 - If the combination is higher than 3H, it is recommended to choose a solid base, e.g. metal plinth or plinth with metal frame;
 - Compositions exceeding 5H height must be mounted to the wall;
 - Additional mounting to the wall and strengthening with wood screws is recommended for cabinets with hinged doors or drawers.

Cabinet fixing

- 6H cabinets always must be fixed to the wall. Wall mount fittings are included with 6H cabinets, additional order is not required. Mounting to the wall is chosen by installer according to the wall type.



Planter box fixing

- Planter boxes are attached to the top panel with screws. Screws are included in the kit.



Colour of the connection

- Bookcase (C4N120, C5N120, C6N120), cabinets (C3S160, C4S120, C4S160, C5S120) and wardrobes (C4S121, C5S121) have visible connection on the backside.
- When ordering bookcase in two colours (C4N120, C5N120, C6N120), the colour of the connection will also be visible on the backside of the cabinet.



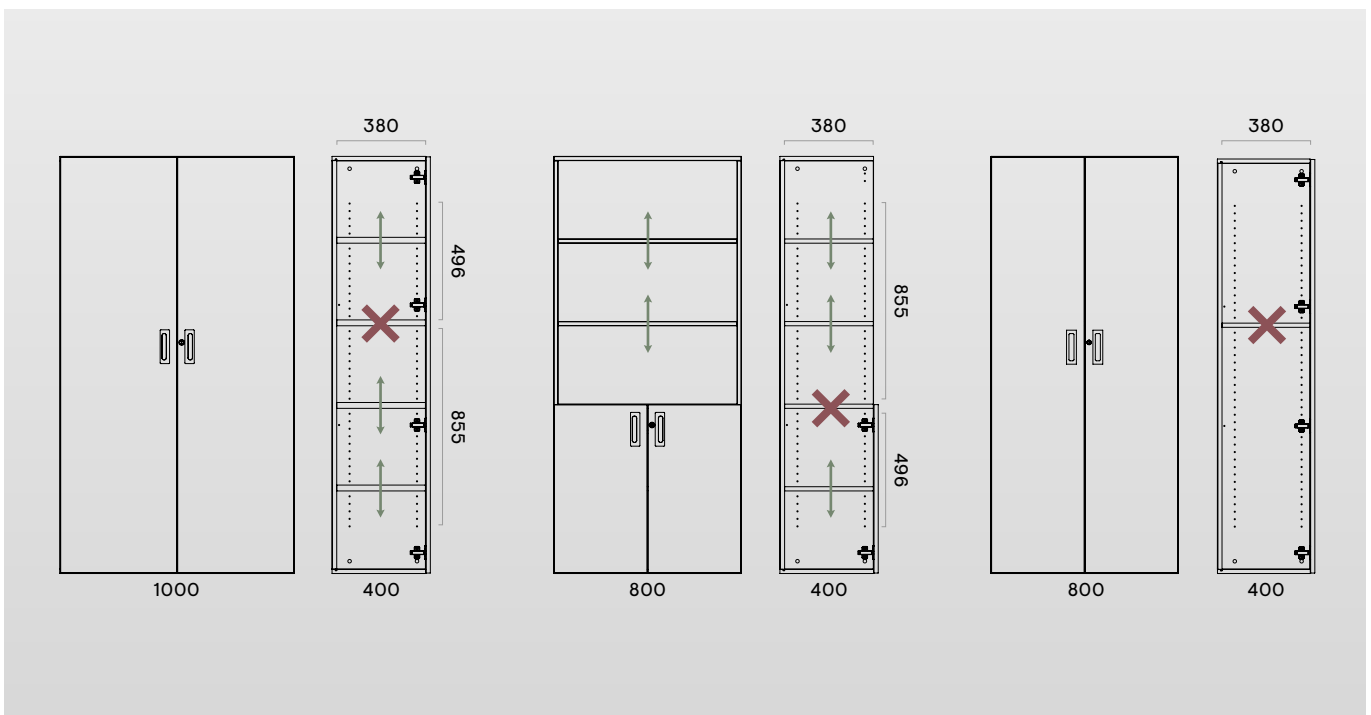
Sliding doors

- In the open position, the sliding inner (right) door is visible. There is a gap of 25 mm between the handle and the edge of the left door. Door brakes can be re-assembled (only for cabinets with type “C” handle) if required, and the door will fully open (more information in assembly scheme).

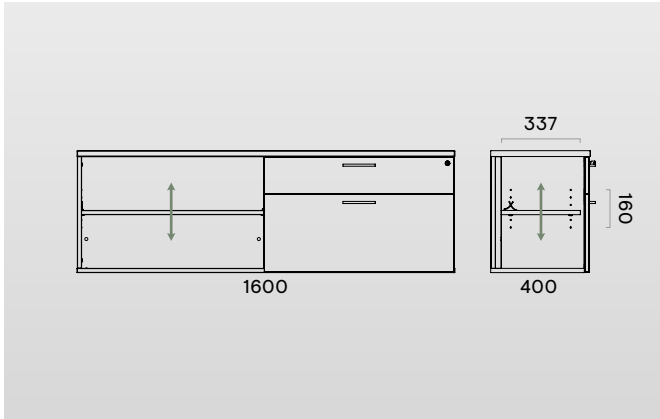


Shelves

- At least one fixed shelf (COZO34, COZO345) or one metal shelf (COZO38, COZO39) must be ordered with 4H, 5H and 6H cabinets with doors and without shelves.
- Shelf adjustment:
 - Bookcase shelves are always fixed;
 - Cabinets and wardrobes 4H-6H have one fixed shelf on the level of the handle (used for locking). Other optional or included shelves can be adjusted in a free space every 32 mm, leaving a minimum ~170 mm space on top and bottom.



- Cabinets with drawers shelves in the open space can be adjusted vertically by 160 mm;



- Additional shelves can be ordered for the lower part of the wardrobe.



Bases

- All bases (plinth, legs, etc.) are slightly recessed from the back of the cabinet due to storage stability and design. Please note that the cabinet cannot be placed against the wall completely if there is a floor plinth.



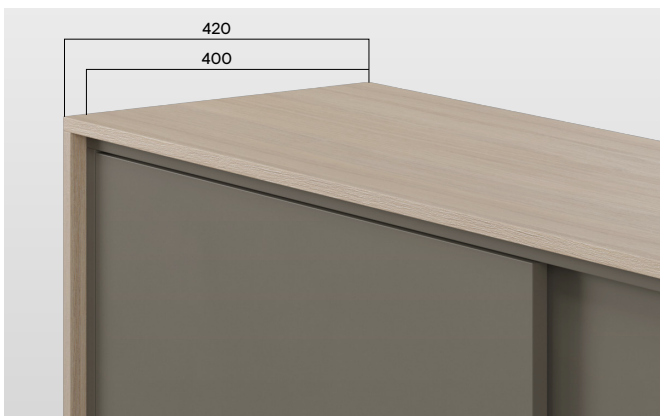
- Central legs (C0Z004, C0Z122, C0Z162, C0Z006) of 1200 mm and 1600 mm width cabinets can be mounted in 2 positions, so it is possible to choose the less visible option.



- Cabinets with drawers and shelves (C2S150; C2S151) cannot be ordered with plinths.

Back panels

- Bookcases and cabinets with sliding doors are 400 mm deep. MFC back panels are 420 mm deep and will stand out by 20 mm.



- Fabric and PET back panels of 3H and higher cabinets (C3S160, C4N120, C4S120, C4S121, C4S160, C5S120, C5S121) are made of two pieces.



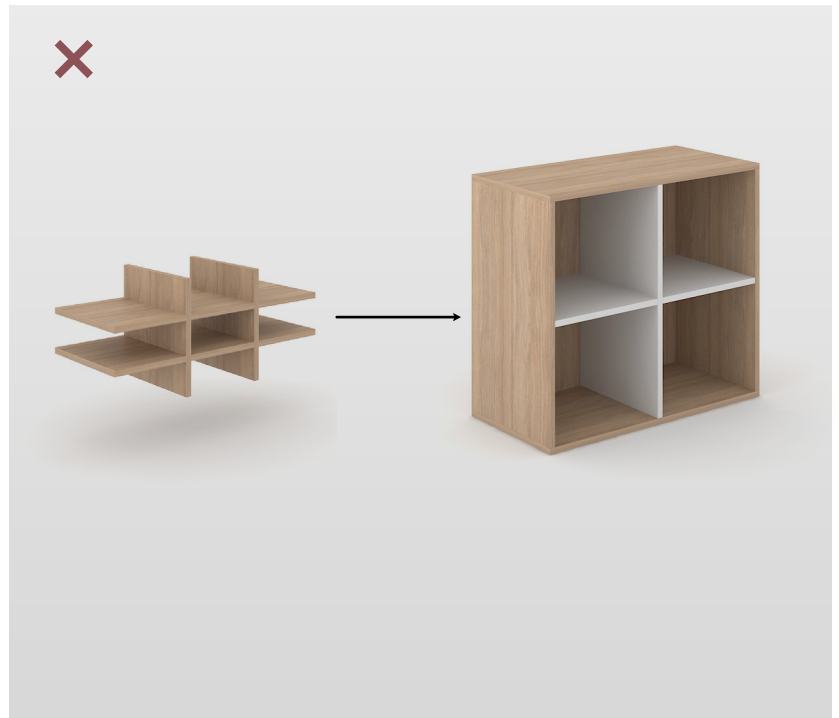
Cushion

- Cushion is suggested for 1H and 2H cabinets and only for short sitting periods. 1H and 2H cabinets can hold up to 110 kg.



Additional parts (“Pigeon holes”)

- Not suitable for bookcases with vertical dividers;
- Not suitable for wardrobes;
- Not suitable for cabinets with sliding doors;
- Important! Please note that “Pigeon holes” weigh about 8 kg and should be factored in the shelf and cabinet loading capacity;
- Shelves must be adjusted according to “Pigeon holes” height (334 mm).



A4 suspension files

- A4 suspension files can only be hung on lateral filing metal shelves in cabinets with hinged doors. The suspension files in cabinets with sliding doors will not fit on metal shelves (COZO40, COZO41, COZO42, COZO43).



Pull-out metal filing cradles

- When ordering cabinets with pull-out metal filing cradles, it is recommended to order counterweights or fix cabinets to the wall or other stable furniture. Please note that in the set of metal pull-out filing cradles (2 pcs.), there is an anti-tilt mechanism, i.e. both cradles cannot be open simultaneously.
- If ordering 2 or more cradles, largest possible number of anti-tilt sets must be ordered (ex. If ordering 4 cradles – order 3-unit set with anti-tilt + 1 without anti-tilt. If ordering 5 cradles – 3-unit set with anti-tilt + 2-unit set with anti-tilt).





















- The warranty period includes the period during which the Buyer could not use the Product because of its defect.
- Warranty repairs do not represent the start of a new warranty period.
- The furniture covered with the natural wood veneer may not have the same wood structure and pattern. There might also be minor cracks or branch structures typical for natural wood. Over the time Product's coating shade might also change. This is not perceived as Product's quality defect or the deterioration of the quality.
- Manufacturer in no event shall be liable to any customer or any third party for any consequential, economic, indirect or incidental damages arising from the product defect, except cases where the consumer protection laws stipulate otherwise.
- Manufacturer is not responsible for damages which occurs to the Product in transit. Visible damages in transit shall be noted on the delivery note (CMR) in writing immediately after receipt of the Products and the Manufacturer shall be informed accordingly.

Non-standard furniture

- Non-standard furniture, which is made by unique, custom design or which has non-standard modifications, functions or other non-standard construction solutions, considering NARBUTAS standard furniture range at the time, 2 years warranty applies.

Exclusions

Limited warranty applies for these products and components:

- 5 years warranty for SILENT ROOM acoustic pods, height adjustment mechanisms for ACTIVE, EASY, JAZZ, MOTION, MOTION EXECUTIVE, MOVE&LEAD desks, drawers, sliding and tambour type doors, gas lifts, castors, glides, worksurfaces, foam parts, upholstery materials (fabric, textile).
- 2 years warranty for height adjustment mechanisms for B ACTIVE, ONE desks, furniture electronic components, leather coverings, concrete bases, foldable frames, adhesive and suspension fittings.

Warranty service is applicable only if the Product defects are identified before the end of the warranty period. In any case, the warranty is not valid and is not applicable:

- If the Buyer or a third party dismantled, irresponsibly transported Products, improperly assembled them, damaged or lost their parts.
- If the fault or defect in the Product is caused by nonconformity of furniture installation, care and exploitation instructions.
- If the Product was used or exposed to unsuitable environmental conditions (excessive humidity, exposure to chemicals or outdoor settings if not meant to be).
- If defect appears because the Buyer of the Products assembled or temporarily stored it in the premises where the construction or decoration works took place.
- If the breakdown or defect appeared because of force majeure or accidents.
- If the Buyer has not informed about the defects and breakdowns within a reasonable time after he noticed or should have noticed the defects.
- If the Product, part or component is considered to be consumable (e. g. light bulbs, batteries).
- For normal wear and tear (e.g., changes in surface finishes due to aging or exposure to UV light), pilling of textiles, wrinkles, scars or other distinguishing marks occurring naturally on leather.
- For glass breakage, mechanical damage and scratches of materials, the damage of Products, and losses occurring during the exploitation of Products due to improper usage or conduct, as well as the non-standard use or improper interference by the third parties (violations).
- For differences in the linearity of grain in melamine faced chipboard and laminates occurring within the same batch, matching of colors, grain or texture.

To the extent allowed by law, any implied warranties are disclaimed and, to the extent they are legally required, are limited in duration of this written warranty. This warranty does not exclude or restrict statutory rights which cannot be excluded by law.
